

PRIVACY POLICY

We only collect information that is necessary to keep in touch with our members and supporters to inform them about our campaign and activities as well as developments at Hinkley Point and within the nuclear industry.

The personal information we collect may include:

- •vour name and title.
- •your email address, phone numbers and postal address.
- donations or subscriptions you have made to Stop Hinkley
- •feedback you may have submitted

We collect personal information that you may provide to us including when you:

- •sign up as a Member or supporter;
- •sign up to our email updates;
- •make a donation:

We may also collect publically available information.

We will only use your information if we have a legal basis for doing so under current UK data protection legislation, including:

- •Where you have agreed to receive email updates in relation to our campaign.
- •Where using your information is necessary, for example: To process donations;

Where we are relying on this basis of processing you have the right to object to this.

We will keep your information for as long as is necessary for accounting purposes or for other reasonable legal purposes. The retention period will vary according to the nature of the purpose under which the information is held.

We follow strict security procedures in the storage and disclosure of information you have given us and strive to prevent:

- Unauthorised access;
- •improper use or disclosure;
- unauthorised modification; and
- •accidental loss, damage and destruction.

All our data processors who have access to and are associated with the processing of personal information are obliged to respect the confidentiality of the personal information of our email subscribers, members, supporters and all those who engage with us.

We will not sell or give your personal information to any third parties or external organisations.

You have certain rights in relation to your personal information. They are:

- •The right to obtain confirmation that we are processing your personal information
- The right to access your information;
- •The right to have your personal information rectified if it is incomplete or inaccurate;
- •The right to have your personal information removed or deleted in certain circumstances, for example when you have withdrawn consent to it being used and we have no other basis for processing it;
- •Where you have provided your consent, you have the the right to withdraw consent to the processing of your data (without affecting the lawfulness of processing based on consent before its withdrawal); and
- •The right to require us not to send you marketing communications.

Subject Access Request

You can ask us to confirm if we are keeping any personal information about you and you can also request to receive a copy of that personal information – this is called a Subject Access Request.

To make a Subject Access Request you will need to provide adequate proof of identity, such as a copy of your passport or driving license, before your request can be processed. Once we have received your Subject Access Request and proof of identity, you will receive a response from us as soon as possible.
